Storage Properties	 Storing in high temperature and humidity would cause indurate. 1. Taigal CDP offers a good protection on colloid due to its slightly anionic character. It creates a temporary affinity on cation of the dyestuffs to prevent CDP fabrics from absorbing cationic dyestuffs too soon. 2. Taigal CDP offers an excellent anti-precipitation effect in the dyeing bath of CD-PET/RAYON so stops the formations of spot, decreases pollutes on vat wall, and reaches required color appeal and fastness. 3. Taigal CDP can also provide excellent dispersing and leveling effects to disperse dyestuffs. While applying cationic dyes and disperse dyes in the same bath, the anion dispersing properties of disperse dyestuff and cationic dyestuff will create a complex compound and brings the dispersing effect down. Taigal CDP gives disperse dyestuff an very good dispersing effect, no elimination on color may
